Notice

(Steps Involved in FYUGP 1st Semester Admission 2026-27)

- Visit notice section of the College Website (www.chaiduarcollege.ac.in) or Samarth Website (<https://assamadmission.samarth.ac.in>) to check your selection status in the merit list.
- If your name appears in the merit list, then visit college on the notified days of admission (June 4-6, 2026 for 1st Merit List and June 10-12, 2026 for 2nd Merit List).
- **The 1st Merit List admission on June 4, 2026 will commence from 11 a.m. due to the FYUGP 2nd semester examination in the morning session.**
- Each merit listed student will first submit the fruit sapling to express their commitment to the Mission Green Earth in Room No. C - 01 and then proceed to respective departmental office for document verification.
- Each student must furnish the following self-attested documents at the time of document verification:
 - Samarth application form
 - Sapling submission proof
 - Domicile proof for fee waiver category student
 - Income proof certificate (either ration card or income certificate) for fee waiver category student.
 - Caste certificate (if applicable)
 - NCL certificate (for OBC category APL student)
 - Duly signed self-declaration form (available in the college website)
 - Anti-ragging affidavit (generated from the anti-ragging website <https://antiragging.in>) (**Institution phone number to be used: 78969-21031**)

** Students of APL category and self-financing courses (B. Com and B. Voc.) need not produce income certificate or ration card and the self-declaration form.*

- If a student is selected for admission under fee waiver category, then the concerned student has to accept the admission offer of the college soon after document verification and then he/she can leave the college.
- If a student is not selected for admission under fee waiver category (i.e., selected under APL category), then the concerned student has to accept the admission offer of the college soon after document verification and then he/she has to submit the fee payment receipt to Shri Debajit Borah in the Office of the Principal before leaving the college. **Payment procedure is explained later.**

*Please note that the college cannot grant admission to a student through the Samarth Portal if the student does **not** accept the admission offer of the college soon after the document verification. If the student does **not** accept the admission offer of the college, the student cannot claim his / her admission in the college at a later stage. Also if a student accepts the admission offer of the college before document verification but he / she is denied admission during document verification for any genuine ground, he or she cannot claim admission in the college by virtue of the fact that his or her name was in the merit list or he / she accepted the admission offer of the college.*

- For Spot Admission on June 15, 2026 (10 A.M. – 3 P.M.), only those students will come to the college whose names appear in the Spot Admission List which will be prepared on the basis of different criteria set by the college.

Payment Procedure for APL Students and Self-Financing Courses

For B. A.:

SBI Collect → Chaidurcollege → Admission B. A. 1st Year → Pay ₹ 7180 by using UPI or Card

For B. Sc.:


SBI Collect → Chaidurcollege → Admission Fee for B. Sc. 1st Year → Pay ₹ 7480 by using UPI or Card

For B. Com.:

SBI Collect → Chaiduar College, Commerce Stream → B. Com. Admission → Pay ₹5000 by using UPI or Card

For B. Voc. (Mass Media):

SBI Collect → Chaiduar College B. Voc. Fund → Mass Media Admission → Pay ₹7000 by using UPI or Card
