In view of the Corrigendum Notice (No. E – 413540/2026/223, dated 10th August 2026 – copy enclosed herewith) of the Higher Education Department of the Government of Assam, the amount to be paid by the FYUGP 2nd and 3rd year B. A. and B. Sc. students (2026-27 session) with arrear / backlog is revised as under:

Admission Fee of B. A. 2 nd & 3 rd Year with Arrear / Backlog	:	₹3375

Dates of Admission: **August 11 – 14, 2026** (No more extension will be given for admission)

Please note that BPL students with backlog/arrear who have already taken renewal admission by paying the full admission fee, the 50 percent of the said fee will refunded to their bank account once they submit a written application (between August 17 – 20, 2026) along with self-attested mark sheets of the last two semesters, front page of the active bank passbook (own) and the payment receipt of renewal admission.

For the FYUGP 3rd year students, as of now, only the 3rd semester mark sheets will be taken account. Once the FYUGP 4th semester results are declared, dates will be announced for payment for those students who will have arrear / backlog in the 4th semester.

CORRIGENDUM

In partial modification of the Executive Order issued vide No. E-413540/2026/204 dated 04-07-2026 regarding implementation of the Fee Waiver Scheme under the Higher Education Department, it is hereby informed that students having arrears/backlogs in the previous academic year(s) shall also be eligible to avail the benefit of the Fee Waiver Scheme, subject to the condition that only 50% (fifty percent) of the applicable fees shall be waived in respect of such students.
